In a famous passage, Rutilius Namatianus, returning to Gaul from Rome in 416, records that he saw the walls of Cosa in ruins from his ship: that he risked going by sail suggests that the Via Aurelia was in bad repair. The apogee of the villa landscape comes thus at the beginning of our period, between the midfirst century B.C. (after which no villas of this type were built), and the end of the first century A.D. 245 sites were found with *sigillata italica* (pers. com. E. Regoli), and of these almost half may be interpreted as villas (fig. 2: within the systematic samples 44% are villas or villages). Some new small sites were built towards the watershed, as the displaced peasantry cleared the only available land. The principal characteristic of the landscape is the villa.

This mixture of concentrated settlements and a visible element of rural dispersion was also very common in Italy – and not at all common in the Agro romano, where most settlement was apparently highly fragmented, and is almost invisible in our documentary sources.²⁹ This area is on the very edge of the Agro romano, and not far from the lands of *incastellamento* in the rest of Lazio, made famous by Pierre Toubert's monumental study.

Who really ruled Albano, in fact? Until the very end of our period, not its bishop, who is so evanescent in our sources; indeed, even before cardinal bishops became usually foreign (which is by the 1050s in Albano's case), I would guess that the bishop very often resided in Rome, as did other suburbicarian bishops such as those of Porto and Silva Candida, even if we do not know where.
